Under the theme "TERRITORIAL INTELLIGENCE AND GLOBALIZATION. TENSIONS, TRANSITION, AND TRANSFORMATION", the INTI International Conference La Plata 2012 is an open invitation from the INTI (International Network of Territorial Intelligence) which is extended to various scientific communities from all continents: it is a space-time which aims for the co-construction of Territorial Intelligence knowledge and experiences within an ever more complex framework and the crisis of globalization. It's precisely there where tensions arise and challenges emerge in regions as unequal as the European Union, Latin America, Anglo-Saxon America, the Far East, Middle East, Africa and others. The challenge of socio-ecological transition, in terms of sustainability, might imply worldwide changes in the societies' way of life, as well as the transformation of the subjects of those societies and of more viable and intelligence contribute to the understanding of this complex and multidimensional matter of INTI La Plata 2012.

In Argentina, this conference is held with the support of CONICET (National Council of Scientific and Technical Research), UNLP (National University of La Plata), and the GDRI INTI Groupe de Recherche International in "International Network of Territorial Intelligence", www.territorial-intelligence.eu. Seven research teams from France, Belgium, Spain, Italy and Argentina, as well as a number of national and foreign universities, participate in this particular venue. Also, this event is underwritten by 22 Latin American Universities members of the Latin American Possible Territories Scientific Network.

Objectives:

• To put forth the six INTI GDRI's research themes as to broaden the federal base of research teams in different regions of the world, building on existing projects currently converging toward each theme: 1- Territory, 2- Intelligence, Communication, Culture and Education, 3- Governance , 4- Observation, and two cross-cutting themes: Gender and Vulnerability

• To exchange views, experiences, and progress on the implementation of a dozen scientific methods and INTI (ENTI and TAG) scientific tools developed to solve problems with territorial intelligence.

• To contribute to the construction of a theory of Transformation with Territorial Intelligence with the vital support of various scientific disciplines and to promote Socio-Ecological Transition scenarios which articulate the scientific world with our institutions and territorial communities.

The XI International Conference INTI La Plata 2012, has as background on the ten preceding ENTI International Conferences held in various European countries -France, Spain, Belgium, Italy, Romania. The last of which was the first INTI International Conference in Belgium at the University of Liege in September 2011. Other antecedents are the ITIS I to VI International Territorial Intelligence Seminars organized by our TAG Team, which were held in various countries throughout Latin American -Argentina, Uruguay, and Colombia- between the years 2009 and 2011. Moreover, the symposium "Territorial Dynamics and Social Economics" Tours, March 2012, and the GDRI INTI Salerno Seminar, June 2012, have been added to our GDRI schedule, both events are expected to prove valuable in order for the INTI La Plata 2012 XI to have previous rooms for

TECHNICAL DETAILS OF ABSTRACT AND FULL COMMUNICATIONS SUBMISSIONS

ABSTRACTS: FORMAT GUIDELINES

- The abstract is to be submitted in English as well as in its native language (Spanish, Portuguese, French).
- Maximum word length: 400 words (in English).
- Such abstract must include the purpose, relevant results, and conclusions.
- Letter Arial 11, spacing 1.5 lines.
- Paragraph Alignment: justified, without indentation or spacing front / back.
- Margins: top and bottom of 2.5 cm and left and right 3 cm.
- Also, the author must be provide up to 4 keywords (both, in English and in the original language).
- The abstract should not contain bibliographical references or quotations. The abstract may include non– literal direct quotes, inserted in a sentence, according to the following format: in parentheses, indicating the author's name and year, separated by comma (Martinez, 1998).

FULL COMMUNICATIONS: FORMAT GUIDELINES

- It is be submitted in one of the four (4) Congress languages: Spanish, Portuguese, English or French. Written in word processor (.doc and other compatible formats)
- Length: Up to 7 (seven) pages figures and tables included-.
- It has to follow this structure: title and subtitle, authors, abstract and keywords. After this section, full development should proceed.
- Paper size: A4.
- Top and bottom margins: 2.5 cm.
- Left and right margins: 3 cm.
- Font: Arial.

- Main text font size: 11.
- Spacing: 1.5
- Paragraph Alignment: justified, without indentation or spacing front / back.
- Title: Arial 12, capital letters, bold.
- Subtitles: Arial 12, capital letters, bold.
- Author/s: Arial 10, lower case, right-aligned to space and a half of the title.
- All submissions must include the following author data: academic title, full address, current institution, mailing address and email address.
- Footnotes: Times New Roman, size 10, single spacing, justified and numbered with decimals (1, 2, 3 ...).
- Endnotes: numbered correlatively in the main text and re-typed before the references. Quotations: Direct quotations should be enclosed in quotation marks(not in italics). It is advisable not to overuse this kind of quotation. When text has been omitted within a quotation, it should be indicated by placing three points within brackets.
- Bibliographical References: Follow the Harvard- APA system.
- Bibliographical references should be enclosed in parentheses in the main text. If the text does not explicitly cite the author's name, then after the citation enclosed in parenthesis should follow (author's last name [comma], year of publication: [colon], page / s which is the segment referred to). Example: (Garcia Ballesteros, 1998: 22).

However, if the name of the author does appear in the text, then, only the year of publication and pages should be enclosed in parentheses. Example: As Garcia Ballesteros (1998: 22) states....

This information should not be a footnote.

- All references that appear in the body of the text must then be developed in full in the bibliography section.
- The maps, graphs, diagrams and tables should be submitted in black and white or grayscale. All figures - photos, maps, graphs, and illustrations- should be embedded to the text in JPG format. The size of such figures should not exceed the typographic frame given by the margins.

MODES OF PRESENTATION

The Scientific Committee will decide which mode of presentation fits better each accepted work: Oral Paper Presentation or Poster Presentation.
